# **Embedded change** and transaction logging


BusinessByDesign has been built from the beginning to support audits regardless of their nature financial, compliance or process. You will always know exactly who did what and when in the system.





#### Flexible intuitive help








# True batch, lot and serial number traceability

Business ByDesign supports batch, lot and serial numbers. Serial number in Serial number and Batch in Batch tracking will be officially released as of the 1802 build.

Navigator Business Solutions is an active partner working with SAP's development program. Embedded Warranty tracking allows the solution to auto associate warranties with serial numbers as they are shipped.





#### **BoM Revision Control**

Business ByDesign has very strong Bill of Materials (BoM) Revision control and revision tracking capabilities, allowing change tracking to BoM and BoM Routings with effective dates. This means you have visibility into all past revisions of every BoM including what revision was in place for any given Production Order. ByD also supports BoM variants and tracks changes to Variants as well. The system tracks the user ID/date time for all changes.






## **CAPA - Corrective Action - Preventative Action with Quarantine**

Navigator Business Solutions has enhanced SAP Business ByDesign to support robust CAPA tracking and reporting. The Navigator delivered solution supports Case creation, Initial Risk Assessment, Occurrence rating, Detection Rating, and RPN (Risk Priority Number), Containment and Recall.

You can define single or multiple root Causes and Create and Track you Action Plan(s). For recall support the system can be configured to identify all current stock, deliveries and production of affected raw material or finished goods. You can identify and quarantine all affected stock from a single screen.





#### **Supplier Products Approvals**

Using product and supplier approvals we can ensure that materials are only sourced from approved suppliers. The system can be configured to mark products as restricted and thus requiring sourcing from an approved supplier list. Along with supplier approvals the system tracks whom approved the supplier and the date/time of the approval






#### **Customer product approval**

Using customer product approvals the solution can be configured to flag any product as being restricted to customer, or customer location. This ensures that only approved items are shipped to the customer or to an approved location.

Approvals are user ID and date/time stamped. Certifications and documentation can be attached to the approvals as needed.
