Enhanced Outlier Handling When Building Machine Learning Cockpit (MLC) Models

While building an MLC model, you can now choose to replace the outliers with empty strings instead of deleting them to prevent decimation of data. To do so, activate the Activation of Outlier Removal option in the Outlier Removal step of the MLC model training process, and then select Replace. The outliers are now replaced by empty strings and are indicated by # in the Modified Data chart.

Identify and Resolve Process Communication Errors Related to Partner Solution

Legal Entity Identifier has now been enabled for mass data change for suppliers. You can now export and add or update Legal Entity Identifier information for suppliers via a file upload using the Mass Data Maintenance functionality.

Batch Booking

There have been four new values added to Batch Booking for ISO20022 payments for France,Non-Localized countries and Switzerland.These values can be selected using master data for the house bank accounts.

Based on the values selected in the Batch Booking for ISO20022 payments field, the batch booking tag will contain different value in the payment file.

Listed below are the new values and the various scenarios for each of the values:

• 1-Enabled

- If the Batch Booking is set to 1- Enabled, then the batch booking tag will contains the value true in the payment file.
- 2-Disabled
 - If the Batch Booking is set to 2- Disabled, then the batch booking tag will contains the value false in the payment file.
- 3- Batch Booking Tag Empty
 - If the Batch Booking is set to 3 Batch Booking Tag Empty, then the batch booking tag will contain empty in the payment file.
- 4- Batch Booking Tag Removed
 - If the Batch Booking is set to 4 Batch Booking Tag Removed, then the batch booking tag is not present in the payment file.

Country/Region-Specific Changes

The following functions are new or have changed for specific countries/regions:

Austria

Sales Quote (Interactive Form) has now been enabled for Austria.

China

Direct Cash Flow Statement

If the scoping question **Do you want to enable default Cash Flow key for relevant transactions** has been selected in the system for the direct cash flow statement for other countries, then the cash flow key **CF099** will be used by default in bank statements, petty cash transactions, and journal entry vouchers. Once the scoping question is selected, the field **Use Default Cash Flow Key** will appear in the **List of countries relevant for generating Direct Cash Flow Statement** Business Configuration fine-tuning activity. It must be checked against those countries that require the default cash flow key.

Croatia

The deferred tax functionality is now enabled for the sales side. Previously, it was only enabled for the purchase side.

Israel

When clearing invoices that contain supplier charges, the withholding tax is not considered while calculating the final amount.

Allocation Number

The Allocation Number field is now visible in the Journal entry screen of both the customer and supplier invoices.

Italy

Upon cancellation of the credit memo, the credit memo amount should be deducted from the tax exemption certificate.

Payment Format

In Italy, version 9 has now been enabled for the payment format for SEPA CT and DD with XSLT.

Mexico

A new tax code 19 (Domestic Purchase - Goods and Services (Zero Rate)) with 0% tax rate has been delivered to comply with the latest regulations.

Spain

Credit memos which are created with reference to more than one supplier invoice will now be included in the EC Sales List return and will not throw any warning.

United States

From January 01, 2024, the Expense Reports in U.S. reflect the updated Standard Mileage Rates.
